		<ul> <li>Students in year 7 and above should also wear face coverings in classrooms unless medically exempt or where wearing a face covering would impact on the ability to take part in exercise or strenuous activity, e.g., PE lessons. This is a temporary measure.</li> </ul>	
		<ul> <li>In primary schools, we require staff and adults to wear face coverings when moving around corridors and communal areas. We do not require pupils to wear face coverings. LOCAL STM RESPONSE – unless exempt, parents/carers are asked to always wear face coverings whilst on school premises both inside and outside.</li> </ul>	
		<ul> <li>Face coverings are required to be worn by adults and students when travelling on school buses and public transport.</li> </ul>

		<ul> <li>Handwashing / sanitising is scheduled into the school day. It takes place as a minimum: when students, staff or visitors enter the school; at break; before and after lunch; before leaving school; whenever the toilet is used. All students in year 7 and above sanitise hands at the beginning and end of every lesson.</li> <li>Handwashing routines are demonstrated in all relevant locations.</li> <li>Hand driers have been decommissioned and paper towels are provided.</li> <li>Checks are scheduled during the day on stocks of hand sanitiser, soap and paper towels. Steps are taken to ensure that there is sufficient supply in school.</li> <li>Ensure good respiratory hygiene by promoting the 'catch it, bin it, kill it' approach.</li> </ul>	
		<ul> <li>Posters remind students and staff about the importance of the approach and handwashing and are displayed around the school, particularly by washbasins/ toilets and at entry/exit points.</li> <li>Primary pupils are supported to ensure hygiene routines are undertaken regularly and effectively.</li> <li>The location of bins around the school is checked and more are ordered if necessary.</li> <li>A schedule for bins to be emptied / disinfected is in place and is adhered to.</li> <li>Students using public transport are reminded of the need to wear face coverings/masks.</li> <li>A stock of 3 ply disposable face coverings is maintained and made available for staff, visitors and students as required.</li> <li>Introduce enhanced cleaning, including cleaning frequently touched surfaces often, using standard products such as detergents.</li> </ul>	
		<ul> <li>The school's Site Manager ensures delivery of the induction package to cleaning staff, so they fully understand their role in preventing the spread of coronavirus.</li> <li>The cleaning schedule is reviewed and if necessary additional staff hours are provided to ensure that cleaning standards are adhered to.</li> <li>Enhanced cleaning routines are in place across all schools.</li> <li>Stock checks and stock control are maintained.</li> <li>The canteen and catering areas are subject to enhanced cleaning routines.</li> <li>6. 		<ul> <li>Staff are supplied with PPE when supervising a pupil who has symptoms of COVID-19 (if 2m social distancing cannot be ensured) and for the provision of routine intimate care to pupils that involves the use of PPE.</li> <li>Gloves and aprons are provided for cleaning staff.</li> <li>Face masks are worn by staff when cleaning visible bodily fluids from suspected COVID-19 case.</li> <li>Stocks of PPE are regularly monitored and replenished.</li> <li>Evacuation chairs have PPE packs with them which are replenished upon use.</li> <li>Keeping occupied spaces well ventilated</li> </ul>	
		Once the school is in operation, it is important to ensure it is well ventilated and a comfortable teaching environment is maintained.

		<ul> <li>Mechanical ventilation systems – these are adjusted to increase the ventilation rate wherever possible and checked to confirm that normal operation meets current guidance (if possible, systems are adjusted to full fresh air or, if not, then systems are operated as normal if they are within a single room and supplemented by an outdoor air supply).</li> <li>Natural ventilation – opening windows (in cooler weather windows are opened to provide constant background ventilation and opened more fully during breaks to purge the air in the space). Internal doors are opened where necessary natural ventilation – external opening doors are also opened (if they are not fire doors and where safe to do so).</li> </ul>	
		<ul> <li>School has access to and observes Health and Safety Executive guidance on air conditioning and ventilation during the coronavirus outbreak and CIBSE coronavirus (COVID-19) advice.</li> <li>The government is providing schools with CO2 monitors to check on air quality across the site. These have been deployed at the secondary school and are regularly monitored.</li> <li>Engage with Lateral Flow Device Testing</li> </ul>	
		<ul> <li>School leaders understand the importance of twice weekly lateral flow testing for staff and students.</li> <li>All students are recommended to LFD test twice weekly at home and regular reminders are issued via social media, website and other communications.</li> <li>All staff and parents must engage with NHS Test and Trace immediately.</li> <li>Local health protection advice will be followed in the event of a local outbreak.</li> <li>All relevant information is available on the College website.</li> <li>Manage confirmed cases of coronavirus (COVID-19) amongst the school community.</li> </ul>	
		<ul> <li>Contact details for the local Public Health England team and local authority health and safety team are readily to hand.</li> <li>In line with current guidance, a clear process is in place to notify the appropriate authorities of any cases that test positive (e.g., the Trust, the Local Authority, the DfE/Local Health Protection Team as required).</li> </ul>

		<ul> <li>A spreadsheet is maintained to record all staff and pupils who are self-isolating who have tested positive. These spreadsheets are kept up to date.</li> <li>Use is made of any template letters provided by Public Health England / local authority as directed locally.</li> <li>The Toolkit/Action Plan for confirmed COVID-19 cases in school is followed for all confirmed cases.</li> <li>Support and advice are sought from the Trust for any queries/complex cases. Further advice is sought from the Local Authority/DfE/PHE as required.</li> <li>11. Contain any outbreak by following local health protection team advice.</li> </ul>	
		<ul> <li>The school responds immediately to advice provided by the local health protection team.</li> <li>Good working relationships are established and maintained, enabling rapid communication with local authorities and local Public Health England.</li> </ul>	
Maintaining effective social distancing to prevent spread of COVID-19		<ul> <li>Current government guidance is being applied alongside local measures.</li> <li>Expectations of social distancing are established and communicated to all staff and students regularly. For staff these include expectations on social distancing at all times.</li> <li>Clear social distancing signage is in place throughout the school.</li> <li>Spare chairs and desks have been removed.</li> <li>Classrooms are well ventilated.</li> <li>Outdoor learning is incorporated into the curriculum where possible, outdoor PE equipment is not used without thorough cleaning between usage of students from different year groups.</li> <li>Whole staff meetings, congregational assemblies and other large face to face gatherings are reduced and mask wearing encouraged in these circumstances.</li> <li>Teams continues to be used, as a reasonable option for meetings.</li> <li>Access to toilets is planned and managed to avoid large groups/queues from forming.</li> <li>Activities that involve shared resources/equipment are avoided.</li> <li>Where possible, one-way systems are implemented for circulation. Routes are clearly marked with appropriate signage.</li> <li>Appropriate signage, screens and floor markings are in place to protect reception staff and other office staff so that they can remain at a distance of 2m from any visitors. Staff and parents understand and act on their obligations under NHS Test and Trace to get tested if they show symptoms of COVID-19.</li> <li>Appropriate guidance is followed according to the result of the test.</li> <li>Staff, students, and parents have been briefed regarding the need to self-isolate with symptoms.</li> <li>Procedures are in place to ensure that staff, students, or visitors do not enter the school if they have COVID-19 symptoms / have been told to self-isolate by a healthcare professional until it is safe to do so according to the latest government guidance.</li> <li>Any staff/students who become unwell at school must be isolated immediately and sent home as soon as possible with arrangements made for them to take a test under NHS Test and Trace.</li> <li>A room and separate toilet have been designated to accommodate any suspected case whilst they are waiting to be collected. Additional spaces have been identified in the event of multiple simultaneous cases arising.</li> <li>Arrangements are in place for staff supervision of any student displaying COVID-19 symptoms (2m distancing should be observed and where this is not possible, they should wear suitable PPE).</li> <li>Staff and student absence related to COVID-19 is monitored and carefully tracked so that no students or staff are accepted back into school before the incubation timeline has elapsed as set out in the latest government guidance.</li> <li>Arrangements are in place to notify the Trust/Local Authority of any students or staff who test positive for COVID-19.</li> <li>Students suspected of having COVID-19 will be sent home until confirmation of a test result under NHS Test and Trace is received.</li> <li>The Toolkit/Action Plan for confirmed COVID-19 cases in school is followed for all confirmed cases.</li> <li>Support and advice are sought from the Trust for any queries/complex cases. Records are kept of this and regularly updated.</li> <li>Members of staff and students with underlying health conditions have been asked to seek and act on the advice of their GP/consultant/midwife or current government advice.</li> <li>Staff and students are clear about the definitions and associated mitigating strategies in relation to people who are classed as clinically vulnerable and clinically extremely vulnerable as set out in the latest government guidance.</li> <li>For vulnerable staff and students, concerns are discussed, procedures explained, and risk assessments offered.</li> <li>A pregnancy risk assessment is in place for any pregnant staff.</li> <li>If the risk assessment raises any significant issues for pregnant staff who are not in the third trimester, then the full range of options will be considered including working from home earlier than 28 weeks.</li> </ul>
